Rural Settlement Facilities Background Paper (update)

April 2018

1.0 **Background**

1.1 The Kettering Borough Rural Master Planning Report (February 2012) presented findings of the Rural Master Planning Project which was prepared in support of an evidence base to inform the emerging Part 2 Local Plan. The project involved a detailed analysis of the rural area in the Borough including all of the villages, which included a facilities assessment for each settlement. This information now requires updating to ensure that it reflects the current position within each of the rural settlements, as it will be an important consideration in determining the sustainability of each settlement alongside the sustainability assessment criteria used to assess potential housing site and employment site allocations through the Part 2 Local Plan.

2.0 **Introduction**

2.1 Facilities available within each settlement were reviewed in May / June 2015 by officers who visited each settlement. To ensure that any further changes leading up until March 2018 have been captured, a further desk top assessment has been undertaken which has involved reviewing the following sources of information:

- Google maps and Google search
- Parish Council and Village websites

2.2 Facilities recognised as providing a key service to the local community and included within this review are set out below:

- Churches (including chapels and other buildings of religious use);
- Community Buildings (i.e. village halls, community centres, buildings which can be rented for community use, etc);
- Schools (including public children's nurseries, infant, primary and secondary schools);
- Hotels and Bed and Breakfast (including other uses which provide accommodation);
- Public Houses (including working men's clubs and other social clubs which offer bar facilities);
- Retail (includes retail providing day to day retail offer);
- Hot Food Takeaway;
- Restaurants and Cafes;
- Business Units (which offer a service to the local as well as wider community or retail use);
- Doctors / Health Clinics;
- Dentists;
- Opticians;
- Automatic Teller Machine (ATM) / Daily Banking Facilities.

The review excludes the following:

- Businesses which do not provide a service to the local community;
- Allotments, recreation and play areas
- Part-time / limited services [these are noted instead]

2.3 Facilities and Service Mapping

2.4 Table 1 (page 4) provides an overview summary of facilities available in each settlement located within the Borough. These are grouped by village category, which are defined accordingly:

2.5 **Village Category A** - In these locations, there is an emphasis to protect the village's environment and their limited ability to absorb further development. Within these villages development will be on small scale infill sites or sites allocated for rural housing.

2.6 **Village Category B** - These villages are seen as having particularly important Conservation Areas as well as having a particular character and charm, given that these are 'estate villages' associated with the Boughton Estate. It is therefore essential that the character and vitality of these villages is maintained. Therefore in accordance with Policy 11 of the JCS, which allows the designation of sensitive areas where infill development will be resisted or subject to special control, these areas are designated as Category B villages.

2.7 **Village Category C** - These settlements are dispersed in character. Due to their low density and small number of dwellings, these 6 villages (Brampton Ash, Dingley, Orton, Pipewell, Glendon and Thorpe Underwood) are viewed as scattered development in the open countryside. This means that these settlements are not defined by a village boundary; therefore this designation is the most appropriate for these villages within the rural area of Kettering Borough. This approach also means that because of the size of these settlements and limited range of facilities, there are no allocations and therefore no proposed growth in these villages, in order to maintain their scattered village designation and status. Typically, these villages have limited accessibility to local facilities and employment; new development in these locations would not be considered as sustainable development. Development in these locations would also require the need to travel for almost all purposes, which has the potential to have a detrimental effect on the setting and character of these settlements.

2.8 Maps of village facilities for each settlement are provided in Appendix 1. These maps are dated to reflect the snapshot in time they relate to.
