






The target for the repeat incidents of domestic violence cases reviewed at MARAC is that no more than 32.0% of cases over 2009/10 will experience a repeat incident.








































Appendix A: Explanation

The Performance Improvement Bulletin is intended to provide the Crime and Disorder Reduction Partnership (CDRP) with relevant information to assist in the monitoring of performance against the targets identified in the 2008-2011 CDRP Strategy. In doing so, it is intended to identify strategy objectives that require additional improvement and assist in the identification of priorities.

The Performance Improvement Bulletin forms part of a package of products being developed by ComPaSS in consultation and collaboration with key stakeholders through the ComPaSS User Group. These products are to assist CDRPs with the identification of priorities and decision making at strategic and operational/tactical levels commensurate with the stated ComPaSS aims and objectives.

Appendix B: Interpreting the Performance Charts

For each Partnership Strategy target the current performance towards the 2008-11 target will be displayed using the Performance Chart which is explained below.



Appendix C: Data caveats - sources, definitions and time periods

A number of different data sources are used to inform the progress against the Partnership Strategy targets. The below lists for each data source the most recent time period that the data in the Performance Improvement Bulletin will generally cover up until baring any delays in ComPaSS receiving the data prior to the report's publication:

- Police recorded Crime data the most recently completed month
- IQuanta data the month before the most recently completed month
- Police Public Attitudes Survey data the month before the most recently completed month

The following defines specific measures in greater detail:

- Repeat Domestic Crime is the local indicator used to measure Domestic Abuse.
- > The baseline for people killed or seriously injured in road traffic collisions (NI47) is based on a twelve month mean taken from the number of incidents recorded over 2004 to 2006 and is 486 recorded incidents. The target is a twelve month mean for 2007 to 2009 of 430 incidents to be achieved by December 2009.


Appendix D: Interpreting the Performance Charts

Each month end position that is marked on the performance chart is displayed with a particular symbol which provides an assessment of the position against the target trajectory. However, rather than just assessing the position against the trajectory to determine whether performance is 'below target' or 'above target' an approach that has been devised by iQuanta has been adapted and utilised. This method takes a more considered view of performance and assesses whether performance is below target, above target or on target.

This method works by calculating the required reduction in the number of crimes required to meet the target between 2008/09 to 2010/11. From this figure an initial upper limit of 10% of this drop in crimes is set above the target baseline position which reduces over time to zero at the end of the strategy. An initial lower limit of 10% of the drop in crimes is also set which reduces to over time to zero at the end of the strategy.

Once the upper and lower limits have been set the actual performance in a month can be compared with the necessary performance to meet the target according to the target trajectory line and the upper and lower limits can be used to determine how much emphasis to place on the difference between the actual and ideal performance. Three possible situations are distinguished by this method and the table below shows each potential situation and how it is presented on the Performance Charts. The chart to the below right visually illustrates the two limit lines placed against a trajectory line.





Appendix E: Interpreting the Performance Tables

- Current performance against each Partnership Strategy target will be assessed using a Performance Table. Explanations for each row in the Performance Table are provided below.
- Reduction required from current position to meet target a percentage figure of the reduction required from the current position in order to meet the 2008-11 strategy target. If the target has been achieved 'N/A' will be displayed.
- > Long-term trend sufficient to meet target if the long term trend projection is sufficient to meet the strategy target 'Yes' will be displayed in the box in the table and it will be coloured green. If the long term trend projection is insufficient to meet the target this is indicated by a 'No' and the box will be coloured red.
- Performance over the past month the expected performance for the current month is calculated based on performance over the previous twelve months. A red box stating 'Above Expected Level' indicates that performance over the past month is unusually high based on recent trends. This does not necessarily mean that performance is going to be immediately impacted upon, but that this may indicate an area that warrants further investigation. A light green box stating 'In Line' indicates that the current month's performance is in line with performance over the past twelve months and a dark green box stating 'Below Expected Level' indicates that performance is unusually low based on recent trends.
- Comparative performance over the past 12 months ending in current month a percentage figure for the size of the reduction or increase in performance over the past twelve months compared to the performance achieved in the previous twelve months.
- > Distance away from MS group average a percentage figure calculated to show how far away the CDRP value is from the Most Similar Group (MSG) average. This information is taken from the iQuanta system which compares the CDRP with up to 14 other similar units. Most similar groups are used with the aim of making fairer and more meaningful peer comparisons.
- Position against MS group average upper and lower control limits are calculated around MS group average. If the CDRP value is above the upper control limit it is deemed as significantly above the MS group average and will be indicated by a red box stating 'Significantly Above'. If the CDRP value is within the upper and lower control limits, it is deemed as in line with the MS group average and will be indicated by an light green box stating 'In Line'. If the CDRP value is below the lower control limit it is deemed as significantly below average and will be indicated by a dark green box stating 'Significantly Below'.
