The Town Council has highlighted in its' response the specific concern about the proximity of the George Public House to older peoples' bungalows. A variation on the current Premises Licence, as per the application, to extend the hours for live music, recorded music and the sale of alcohol will potentially lead to concerns of public nuisance through noise levels during the early hours of the morning and through disturbances to vulnerable people living in close proximity when people leave the pub again during the early hours of the morning. As previously stated the Town Council request that the existing licensing hours for the George are kept and not extended for live music, recorded music and the sale of alcohol.
